## **2. Educational Background and Business Experience**

Mr. White is the Co-Founder, Managing Partner, and Chief Compliance Officer of Sestante. Mr. White co-founded the Firm in February 2025. Prior to forming Sestante Wealth Management, Dan was Chief Investment Officer of Sestante Capital Advisors, LLC, an affiliated family office. Mr. White, born in 1972, received his Bachelor of Science in Business Administration from the University of Arizona.

## **3. Disciplinary History**

Mr. White does not have any disclosable legal or disciplinary events that would be material to an investor's evaluation of Mr. White or the Firm.

## **4. Other Business Activities**

Mr. White is not registered, nor have an application pending to register, as a registered representative of a broker-dealer, or associated person of a futures commission merchant, commodity pool operator, or commodity trading advisor.

Mr. White is a managing member of Sestante Capital Advisors, LLC and Sestante Capital Management, LLC, both investment advisers relying on the family office exemption. Mr. White is also the managing member of the JDJJ Management LLC which handles the administrative and operations activities of the family offices. Mr. White will spend a portion of his time performing activities on behalf of these entities. These activities could be viewed as creating a conflict of interest in that the time and effort Mr. White spend on behalf of these entities will not be devoted exclusively to the business of Sestante Wealth Management, LLC.

## **5. Additional Compensation**

Mr. White receives additional economic benefits for the direct provision of investment advisory services in connection with the affiliate family offices.

## **6. Supervision**

Mr. White is the Chief Compliance Office of Sestante. As such, he oversees the overall operations of Sestante. Mr. White is required to comply with Sestante's Compliance manual, Code of Ethics and other policies and procedures.
